BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF:.....\$3,575

Our charge includes: staff available 24 hours a day to respond to initial request for service; arrangement conference with family; obtaining, completing and filing of death certificate; completion of necessary permits and authorizations; notification to clergy, newspaper, cemetery or crematory; assistance in securing entitlements; staff assistance prior to and following services. Also incorporated in this basic fee is a proportionate charge for professional licensure, legal, accounting, clerical, secretarial and other administrative responsibilities, insurance, property taxes, utilities, maintenance and repairs. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for Direct Cremations, Immediate Burials and Forwarding and Receiving Remains)

EMBALMING: \$1,300

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. This charge includes disposal of regulated medical waste and compliance with OSHA Bloodbourne Pathogen, Formaldehyde, Hazardous Material Communication and Health and Safety Standards/Regulations.

TERMS OF PAYMENT

We are glad to handle minor cash advances through our office as a convenience to you. These include: Mass or Clergy Offering; Newspaper Notices; Certified Copies of the Death Certificate or Hairdressing. The price for each item will be shown on your Statement of Funeral Goods and Services Selected.

We require all families to make a minimum payment with us in the amount of 50% of your total statement at the time of arrangements to cover these cash advance items and a portion of our charges. Payment may be made by check or credit card. Your payment will be noted on your Statement. Our funeral home will be happy to assist you with Insurance Assignments at no additional cost.

If the individual responsible for the payment of our statement is not a Maryland Resident, payment in full is due at the time of arrangements.

Payment of the balance is due 30 days after the Date of Funeral. Interest will be charged at the rate of 12% per annum (1% per month) on the unpaid principal balance after the due date.
